## Summary of main results

A total of 2,002 delegates from 75 countries gathered in Stockholm, Sweden to discuss and debate the state of global and European health from the perspective of research, methods and practices. A total of 546 delegates (27.3% of all invitees) filled out the evaluation form.

### **Overall outcome:**

*81% of the respondents were very satisfied/satisfied with the Stockholm 2017 conference.*

### **Scientific programme:**

*78% of the respondents were very satisfied/satisfied with the conference programme.*

### **Networking:**

*73% of the respondents were very satisfied/satisfied with the networking possibilities offered at Stockholm 2017.*

### **Skills building activities:**

*80% of the respondents were very satisfied/satisfied with the educational content of sessions. 74% of the respondents thought the sessions were relevant for practice. 66% were very satisfied/satisfied with the questions and discussions in the sessions, 78% with the quality of presenters.*

### **Plenary programme:**

*68% of the participants were very satisfied/satisfied with the plenary programme at Stockholm 2017.*

### **Parallel programme:**

*76% of the respondents were very satisfied/satisfied with the parallel programme.*

### **Conference venue and catering:**

*77% of the respondents were very satisfied/satisfied with the conference venue.*

### **Exhibition:**

*81% of the participants visited the exhibition at least once.*

### **Conference website and information:**

*85% of the respondents were very satisfied/satisfied with the conference website. 78% of the participants were very satisfied/satisfied with the online conference programme.*

### **Conference app:**

*60% of the respondents downloaded the conference app.  
65% of the respondents thought the conference App was good or excellent.*

### **Ljubljana 2018:**

*66% of the respondents are planning to attend Ljubljana 2018.*

# Introduction

The 10th European Public Health Conference took place in the Stockholm International Fairs and Congress Centre (Stockholmsmässan) in Stockholm, Sweden from 1-4 November 2017 (Stockholm 2017). Stockholm 2017 was organised by the European Public Health Conference Foundation, EUPHA and the Swedish Association of Social Medicine (SASM).

A total of 2,002 delegates from over 75 countries gathered in Stockholm to discuss and debate the state of global and European health from the perspective of research, methods and practices. The conference included 7 plenary sessions, 20 pre-conferences, 61 workshops, 43 oral sessions, 40 pitch sessions and 20 E-poster walks.

The theme for the 10th EPH Conference was 'Sustaining resilient and healthy communities'. Resilience is the long-term capacity of a system to deal with change and continue to develop. For a society it involves an ability to deal with political uncertainty or natural disasters in a way that is sustainable in the long-term. Resilience is particularly relevant than in these times of dramatic climate change, long-lasting political conflicts and the global migration that follows these developments. Increased knowledge on how to strengthen resilience of societies and health systems to cope with the current challenges is therefore becoming increasingly important. Good health on equal terms for all is the ultimate goal of our efforts.

Stockholm 2017 was organised in collaboration with a vast number of national and international partners.

Each European Public Health Conference is subject to a multi-layered evaluation. The objectives of this evaluation are:

- to learn from our experiences;
- to improve the organisation of future conferences.

The full evaluation report is an internal document that is distributed to our partners and future organisers. This part of the evaluation, the participants' evaluation, is made publicly accessible on the conference website.

The results presented here are based on the evaluation by the conference participants. 2,002 participants received two emails shortly after the conference inviting them to evaluate the conference through a web-based questionnaire. A total of 546 delegates (27.3% of all invitees) filled out the evaluation form.



# 1. General

81% of the participants were very satisfied/satisfied with the Stockholm 2017 conference.

EPH Conferences are known for the excellent organisation, the high number of participants and a broad programme covering relevant public health topics. Stockholm 2017 was no exception to this with 2,002 delegates, scoring high overall satisfaction by delegates and with a varied programme of plenary sessions, workshops, oral, pitch and electronic poster presentations.


## 1.1 What is your background/work field?



66% the respondents had a background in research/academia. Otherwise, the professional background of the participants showed a balanced mix of policy, practice and training.


## 1.2 How important was the conference theme 'Sustaining resilient and healthy communities' for your work?

## 1.3 How would you rate the conference as a whole?


81% of the participants were very satisfied/satisfied with the Stockholm 2017 conference.



#### 1.4 How would you rate the content of the programme?


Almost 2,002 delegates from over 75 countries gathered to discuss and debate the state of global and European health from the perspective of research, methods and practices. The scientific part of the programme included 7 plenary sessions, 20 pre-conferences, 61 workshops, 43 oral sessions, 40 pitch sessions and 20 E-poster walks.

78% of the respondents were very satisfied/satisfied with the conference programme.

### *1.7. Comments*

Most comments received appreciated the scientific content and technical organisation. The Welcome Reception organised at the Stockholm City Hall was highly scored by the participants.

As the conference is bigger each year, it was quite often suggested to reduce the number of parallel sessions.

## 2. Building Your Skills

Many different sessions were mentioned as being highly appreciated, which highlights the good quality of the scientific programme. All plenary sessions were mentioned, and many workshops, pre-conferences, poster sessions and others were mentioned here.

### 2.1 Which session on Thursday was most interesting to you?

To the questions which session on Thursday was the most interesting, most responses indicated:

1. Plenary sessions:
  - Sharing our common wealth: the need to strengthen the social dimension of the EU
  - Winds of Change: from public to private, from collective to individual. How can public health systems adapt to a changing world.
2. Skills building seminar: Health information is beautiful: communicating health information through infographics


The organisation had given particular attention to identifying the skills building sessions. They were highly appreciated by the respondents.

- Skills building in HTA: how to address the economic impact of public health interventions (3)


2.5. How would you rate the overall aspects of these sessions on the basis of:

a. Educational content




80% of the respondents were very satisfied/satisfied with the educational content.

b. Relevance for practice




74% of the respondents thought the sessions were relevant for practice.

66% of the respondents were very satisfied/satisfied with the questions and discussion in the sessions.


*d. Quality of presenters*



78% of the respondents were very satisfied/satisfied with the quality of presenters.


*2.6. How would you rate the overall impact of these sessions on:*

*a. Knowledge*




78% of the respondents thought these sessions had a good/excellent impact on knowledge.






68% of the participants were very satisfied/satisfied with the plenary programme at Stockholm 2017.

- mental health


### Comments

The main comment received here concerned the high number of parallel sessions, which sometimes caused an overlap of topics and sometimes difficulty in selecting the most interesting sessions. As one respondent observed: *"It is impossible to be in the same time in several places"*.

#### Comments

The catering was highly appreciated by most respondents. Most respondents would appreciate some more sweets/cakes for the coffee breaks. It was stated that more attention should be paid for vegetables.

The conference venue was also highly appreciated. The fact that the Welcome Reception and the Conference Dinner were not available to all participants was mentioned as undesirable. The food at the Conference Dinner was evaluated as poor and not worth its high price.




### 6.1 Did you visit the exhibition area?


- Quite small comparing with previous years

### 7.1 How would you rate the conference website?


85% of the respondents were very satisfied/satisfied with the conference website.



### 7.2 How would you rate the online conference programme?


The preliminary version of the online programme was available in early July and allowed participants to plan their activities before the conference.

### 7.3 How would you rate the information received before the conference?


Most respondents (52%) indicated that the amount of emails received before the conference was fine. However, 10% of the respondents also suggested that it was too much.

Comments included:


- Printed version is good for future references

65% of the respondents thought the conference App was good or excellent.


## 8.1 Did you download the conference app?

65% of respondents were highly appreciative of the conference app.




### Comments


66% of the respondents is planning to attend Ljubljana 2018.
