**Public health for the future of humanity: analysis, advocacy and action**



We will be meeting in Rome at a critical time for our planet. Global temperatures lie far beyond historical records and threats to food and water supply, poverty and inequalities are leading to mass migration and conflict. International agreements, on climate change, nuclear weapons, and much else, are being torn up. Some leading politicians are rejecting the Enlightenment view that policy should be shaped by evidence. At a time when global solidarity is required, populist politicians are exploiting divisions.

The theme of the Congress, *Public Health for the Future of Humanity: Analysis, Advocacy, and Action*, reflects our firm commitment that we, in the global public health community, have an obligation to respond to these new circumstances. We must make visible the threats to health, some of which are already emerging. We must challenge and hold to account those with the power to make a difference. And we must act, making real our commitment to health in all policies.

We, as public health community, have much to contribute and much to learn. As always, we will have many opportunities to share ideas among ourselves, but this year we can enrich our experiences even further, bringing a global perspective to our thinking. ## National Health Workforce Accounts at the 69<sup>th</sup> WHO Regional Committee for Europe, September 2019

During the 69th meeting of the **Regional Committee of the World Health Organisation, EUPHA President Dr Natasha Azzopardi-Muscat** participated in a side event. Using the National Health Workforce Accounts to tackle health workforce challenges. Reference was made to the Global Strategy on Health Resources for Health 2030. By 2020, the following milestones are meant to be achieved:

- (a) All countries have **inclusive institutional mechanisms** in place to coordinate an intersectoral health workforce agenda.
- (b) All countries have a **HRH unit** with responsibility for the development and monitoring of policies and plans.
- (c) All countries have **regulatory mechanisms to promote patient safety** and adequate oversight of the private sector.
- (d) All countries have established **accreditation mechanisms** for health training institutions.
- (e) All countries are making **progress on health workforce registries** to track health workforce stock, education, distribution, flows, demand, capacity and remuneration.
- (f) All countries are making **progress on sharing HRH data** through national health workforce accounts and are submitting core indicators to the WHO Secretariat annually.
- (g) All **bilateral and multilateral agencies are strengthening health workforce assessment.**

The National Health Workforce accounts were presented as a tool to assist in tackling the challenges associated with HRH for health. 2020 will also celebrate the year of the Nurse and the Midwife and will launch the first ever State of Nursing World Health Report.

Dr Azzopardi Muscat thanked WHO for the sterling work being done in the area of health workforce and commended the pragmatic approach being taken towards the deployment of the Health Workforce Accounts. She emphasised that from EUPHA's perspective, the role and contribution of the migrant health workforce needs to feature highly on the HRH policy agenda since this can be an instrument to shape narratives around migration and society. She commended the broad encompassing definition of health workforce being used and asked to ensure that the interdisciplinary nature of contribution to public health should be recognised. She called for further analysis around digital technologies, robotics and AI and their potential and impact on the health workforce. Finally, she highlighted the work being carried out by the EUPHA section on health workforce and reiterated EUPHA's disposition to support the work of WHO in this important policy area. There can be no universal health coverage without the appropriate health workforce.
